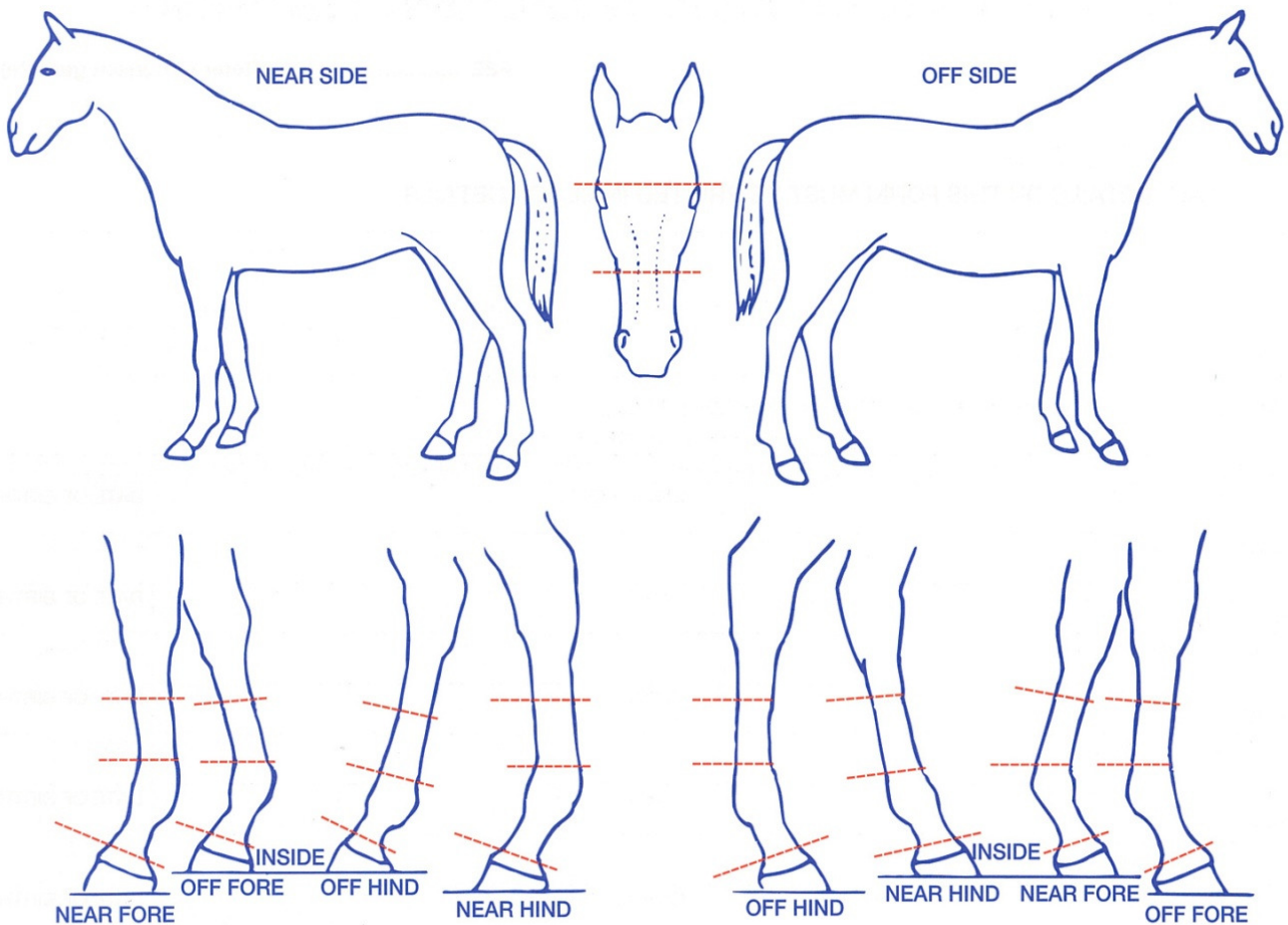

Description

Important information – Please Read Carefully

An application for the naming of this horse will not be acceptable to prior to 1st September in the year following its birth (i.e. when it becomes a Yearling);

When applying for a name physically inspect the horse and clearly draw ABOVE the exact markings and freeze brand symbols appearing on the horse. It may be necessary to clip the area of the brand to clearly identify the freeze brand symbols.

White marking should be shown on both the near and off side diagrams and the position of any scars be marked with an X.

Space is also provided below the diagram of a detailed written description of all identifying marks.

Additionally Section A of the form must be completed in detail and the application signed by the absolute owner/s.

A minimum period of two weeks should be allowed for the time of the lodgement of the Name Application Form until a Registration Assessment Certificate is issued by Harness Racing New South Wales.

Ownership information

Any change of ownership from the Breeder's name to any other party or parties must be notified to Harness Racing NSW.

A breeder is the owner of the dam of the produce at the time of foaling.
