

CORONAVIRUS (COVID-19) - STABLEHANDS & STABLE REPRESENTATIVES NOTIFICATION REQUIREMENTS

21 SEPETMBER 2021

This notice is for all Regional meetings

To facilitate the implementation of Rapid Antigen Testing upon entry to racecourses, Trainers will now be required to nominate a representative to act on their behalf, along with nominating a stablehand to accompany them on HARNESSWEB on their "MY NOMS" tab.

This will be effective for meetings from Thursday 23 September 2021 (therefore the notification deadline for Tamworth will be 10.30am Wednesday 22 September, Wagga and Parkes Friday will be 10.30am Thursday 23 September)

RACE MEETINGS

- If nominating a Stablehand please ensure they are essential to be in attendance at the Race Meeting
- Stablehands or Stable Representatives can be nominated in Harnessweb as soon as the fields are released and before 10.30am the day prior to the meeting.
- Trainers wanting to use a Stable Representative will still be required to provide the appropriate paperwork. <u>TRAINERS REPRESENTATIVE FORM</u>
- Stables with 3 or more runners engaged at a race meeting will be required to apply for an additional Stablehand via email to stewards@hrnsw.com.au. By 10.30am the day prior to the meeting.
- ALL stablehands will need to be nominated on Harnessweb by the required time or entry will be refused to the Racecourse.

TRIALS

- Drivers, Stablehands and Stable Representatives will be required to be notified by 10.30am on Harnessweb the day prior to the trials or entry will be refused to the Racecourse.
- ALL stablehands and drivers will need to be nominated on Harnessweb by the required time or entry will be refused to the Racecourse.

The meeting representative screen shows:

- Information about the deadline for meeting representative submissions [3],
- Nomination information,
- A list of other nominations that are in the same meeting [4],
- the stablehand selection [5] and the trainer representative selection [6] the text fields to enter a stablehand or trainer representative are only displayed if a user selects 'yes' to the respective question.

To make the process easier, trainers will see a drop down list of available licensees when they begin typing a name (i.e. autocomplete). Also, after selecting a stablehand/trainer rep in one nom and then clicking the 'REP' button on a different nom within the same meeting, the trainer will clearly see that they've already selected a stablehand/trainer rep and that changes affect the whole meeting.
