Single letters cannot be used (other than the letter A). The applicant accepts full responsibility should a name be allotted which infringes any trade mark or copyright. Please record name selections in preferred sequence (1 being most desirable, 6 being least desirable). A maximum of eighteen (18) letters (including spaces) is permitted for each horse name. Note that the various State Controlling Bodies do not approve selected names – all names are provided to Harness Racing Australia (HRA) on the afternoon of each business day, with the approved name generally being available on the afternoon of the following business day. Note that, per HRA requirements, a minimum of three (3) names must be recorded below. Applications submitted with less than three (3) names will be returned unprocessed, unless a specific name has been pre-approved by HRA (call 03 9227 3000).



IMPORTANT INFORMATION – PLEASE READ CAREFULLY

An application for the naming of this horse will not be accepted prior to 1st September in the year following its birth (ie: when the horse becomes a yearling). Applications received for horses under one year of age will be returned unprocessed.

Applications may be submitted via email or facsimile (Harness Racing NSW only) however; applications that are not of sufficient print or scan quality will be rejected, as will applications that do not include both pages of the application.

Physically inspect the horse to be named and clearly draw (using the above diagram) the exact markings and freeze brands appearing on the horse. It may be necessary to clip the area of the brand to clearly identify the freeze brand symbols. If any of the freeze brand symbols are indistinct (after clipping the area) please indicate above which symbol, or symbols, are affected so the horse description / appearance can be updated on the national database.

If the horse was born on or after 1 September 2017 the microchip number is to be recorded in the area provided above for this purpose.

White markings should be shown on both the near and off side diagrams and the position of any scars are to be marked with an "X"

Please provide a complete and accurate description of all identifying marks in the area set aside for this purpose above (HORSE DESCRIPTION).

Ensure that Section A of this application is completed as required prior to submitting this application to Harness Racing NSW.

Please allow a reasonable period of time between submitting an application to Harness Racing NSW and the subsequent approval of the name and mailing of the Registration Certificate, particularly if you are submitting the application by standard post (surface mail).
