NOTIFICATION OF A LOAN OF A MARE FOR BREEDING PURPOSES REQUIREMENTS / CONDITIONS

- 1) This notification is to be submitted by the BORROWER(s) to Harness Racing NSW accompanied by the Certificate of Service issued to the OWNER(s) by the Stud responsible for the service and the required processing fee (\$20.00);
- 2) Notifications that are submitted without payment or the appropriate corresponding Certificate of Service will be returned to the BORROWER(s) unprocessed;
- 3) Notifications, Certificates of Service and payment must be submitted by the BORROWER(s) to Harness Racing NSW within one (1) month of the foal being born. Late processing fees may apply for notifications received after this time;
- 4) Additional fees that may be associated with the resultant foal (state notification fees, mare DNA testing fees, state series registration fees, etc) are the sole responsibility of the BORROWER(s);
- 5) This notification is for single season use only (ie: 2018/2019, 2019/2020, etc) and cannot be used to cover multiple seasons. If a mare is to be serviced in consecutive seasons by the same BORROWER(s), a new notification is to be submitted (accompanied by the Certificate of Service and required fee) for each season of service. Notifications submitted with reference to more than a single season will be returned to the BORROWER(s) unprocessed;
- 6) All details on the notification must be completed in full, with particular attention to the recording of the names and signatures of all applicable OWNERS and BORROWERS. Incomplete or illegible notifications will be returned to the BORROWER(s) unprocessed, as will notifications submitted without all names and signatures affixed;
- 7) OWNERS and BORROWERS ensure that all details associated with this notification are fully understood and have been agreed to between all parties prior to the notification being submitted as Harness Racing NSW will not resolve any disputes should they arise;
- 8) Note that the foal associated with this notification, once processed by Harness Racing NSW, will display on the national database and HarnessWeb as having been bred by, and being currently owned by, the BORROWER(s).
