## MARE RELOCATION ASSISTANCE

Harness Racing NSW as of September 1 is providing assistance for breeders to transport their registered Standardbred mares to Yirribee Stud at Wagga or Alabar Farm in Victoria or to other suitable properties indicated on this application.

Although HRNSW is assisting with the transportation costs of the mares, the contract for the mare/s at either Yirribee Stud or Alabar Farm is solely between the owners of the mare and either Yirribee Stud or Alabar Farm. The decision whether to accept the mares rests solely with both venues.

All on farm costs (agistment, working fees, veterinary costs, etc) are at the expense of the owners of the mare/s as per the terms and conditions of the contract with Yirribee Stud or Alabar Farm.

An application to HRNSW from the owners of the mare/s must be completed accurately and approved preferably before transport to either Yirribee Stud or Alabar Farm (or other) is undertaken otherwise assistance may not be provided.

For consideration of an application, HRNSW must be provided with a copy of the contract between the owners of the mare and either Yirribee Stud or Alabar Farm.

HRNSW must also be provided with details of the proposed transportation at the time of the application being made.

Upon approval by HRNSW, transportation costs will be paid upon verification from Yirribee Stud or Alabar Farm (or other) that the transportation of the mare/s has been undertaken.

**Drought Assistance – NSW Breeds Challenge Eligibility Criteria**

**1.1 ELIGIBILITY CRITERIA**

f) Any HRNSW approved broodmare which is transported from NSW to another state to foal or be inseminated, that returns to NSW on or before 30 June 2019 (or a later date if advised subsequently by HRNSW), provided that the foal is notified to HRNSW.

The progeny of such broodmares will not be eligible to apply for dual breeding scheme eligibility outside of the current terms & conditions

For Example (foals):

- i. an approved broodmare that was inseminated in NSW by a Victorian domiciled stallion that foals in Victoria and the foal is notified to HRNSW will be eligible for the NSW Breeders Challenge and VicBred
- ii. an approved broodmare that was inseminated in NSW by a NSW domiciled stallion that foals in Victoria and the foal is notified to HRNSW will be eligible for the NSW Breeders Challenge (including the Blue Series & the True Blue Bonus) but will not be eligible for VicBred.

For Example (insemination):

- i. an approved broodmare that was inseminated in VIC by a Victorian domiciled stallion that foals in NSW and the foal is notified to HRNSW will be eligible for the NSW Breeders Challenge and VicBred
- ii. an approved broodmare that was inseminated in VIC by a NSW domiciled stallion that foals in NSW and the foal is notified to HRNSW will be eligible for the NSW Breeders Challenge (including the Blue Series & the True Blue Bonus) but will not be eligible for VicBred.
