You <u>must ensure</u> that all documents and any outline are lodged with the Appeals Secretary <u>not less than 7 days</u> of the day scheduled for your Appeal. Failure to lodge the required information/documents in time may result in an application to have that evidence excluded at the hearing.
- 3. Do you require any Steward of Harness Racing NSW who participated in the stewards decision for cross-examination at the Appeal hearing?

Your Grounds of Appeal <u>must set out</u>:

- (1) why, in your opinion, the decision of the NSWHR Appeal Panel is incorrect;
- (2) the basis on which you say that the decision of the NSWHR Appeal Panel should be altered/set aside;
- (3) what action you would like the Tribunal to take in the circumstances.
