Failure to lodge the required information/documents in time may result in an application to have that evidence excluded at the hearing.
3. Do you require any Steward of Harness Racing NSW who participated in the stewards decision for cross-examination at the Appeal hearing?

- (1) why, in your opinion, the decision of the NSWHR Appeal Panel is incorrect;
- (2) the basis on which you say that the decision of the NSWHR Appeal Panel should be altered/set aside;
- (3) what action you would like the Tribunal to take in the circumstances.
