

## HRNSW LICENCE UPGRADE APPLICATION

### STABLEHAND, DRIVING TO C GRADE TRAINER / C GRADE DRIVER

Please note that this Licence Upgrade Application is to be completed in full and returned to Harness Racing NSW for processing. Forms received that are either incomplete or incorrectly filled in will be returned to the applicant unprocessed.

#### LICENCE UPGRADE APPLICATION CHECKLIST

Mark boxes with either a **✓** or **X** as appropriate:

- I hold a current Stablehand, Driving licence with HRNSW;
- I have attained the age of eighteen (18) years;
- I have held a Stablehand, Driving Licence for a minimum of six (6) consecutive calendar months;
- I have undertaken a HRNSW Medical Assessment during the last six (6) calendar months (*see note below*);
- I have recently graduated from the NSW Mini Trotters Program and wish to be provided with information regarding the Mini Trotters Progression Scheme Policy Statement to assist in determining whether I am eligible for consideration for subsidisation of licencing and online licence training fees;
- I have (as a licenced Stablehand) already undertaken a Cognitive Test and have enrolled in the HRNSW Education & Welfare Program;
- I have applied for (or already have registered) a Property Identification Code (PIC) for my intended stabling premises.

➤ *If you currently hold a **Stablehand, Driving** licence, and have not undertaken a HRNSW Medical Assessment during the last six months, you **may** be required to do so as part of the overall licence upgrade process. If you currently hold a **Stablehand, Non-Driving** licence, you **will** be required to undertake and submit a HRNSW Medical Assessment with this Licence Upgrade Application (HRNSW Medical Assessment forms are available from our website, [www.hrnsw.com.au](http://www.hrnsw.com.au), or by contacting Harness Racing NSW).*

Note that all Licence Upgrade Applications submitted are subject to review by the Harness Racing NSW Licencing Committee which may necessitate further information and/or undertakings on your part prior to a Licence Upgrade Application being considered or approved.

Further information regarding the documentary and training requirements associated with the licence upgrade you have applied for are contained in the HRNSW Licencing Policy (available at [www.hrnsw.com.au](http://www.hrnsw.com.au) or by contacting Harness Racing NSW) full details of which will be made available to the applicant subsequent to receipt and processing of this Licence Upgrade Application.

Please allow between 2 – 6 weeks for the processing of your Licence Upgrade Application (dependent upon lodgement date). Note that Licence Upgrade Applications received during the annual renewal processing period may be held until existing participant licence renewals have been finalised before being considered.
