



## APPLICATION TO TRANSPORT HORSES OUTSIDE OF REGIONAL BOUNDARIES

As a result of the biosecurity measures introduced by HRNSW, it has been determined that effective 13 August 2021, no horse(s) are permitted to be transported outside of the regional area in which they are registered at that time without the sole permission from HRNSW Integrity division.

Horse(s) which are being transported from other States are permitted and all conditions including the application form must be submitted and approved by HRNSW. HRNSW Integrity division advises that this application is subject to the relevant State or Territory regulations and it is the responsibility of all persons attached to the application (excluding HRNSW Integrity division) to ensure all conditions are met. HRNSW will not take responsibility for any other States or Territories breach of regulations.

Trainers who utilise Veterinarian's or other essential services outside of their regional area, are permitted to continue the use of this service. An application form must also be submitted and the applicable details filed to HRNSW for approval.

### Conditions of Transport –

- a) Any person found to be involved in the transportation or transfer of a horse without the permission from HRNSW and the conditions attached, will be stood down and refused entry and acceptance to any race course or race meeting (including trials) for a period of 28 days. Horse(s) subject of the transportation or transfer will also be stood down from racing for a period of 28 days.
- b) Any horse transported in accordance with all conditions, will not be permitted to be transported outside of the new regional area until 14 days has expired.
- c) Only direct transporting will be permitted. For example, a transporting vehicle cannot transport horses to more than one (1) location at any given time.
- d) All details on Page 2, must be filled out and approved by HRNSW Integrity division prior to any transfer.
- e) All applicable Australian Harness Racing Rules, HRNSW local rules and HRNSW policies are to be met.
- f) HRNSW Integrity division has the sole discretion to refuse any application.
- g) HRNSW Integrity division has the sole discretion to place any further conditions / requirements on any application or make any adjustments to conditions as HRNSW sees appropriate.
